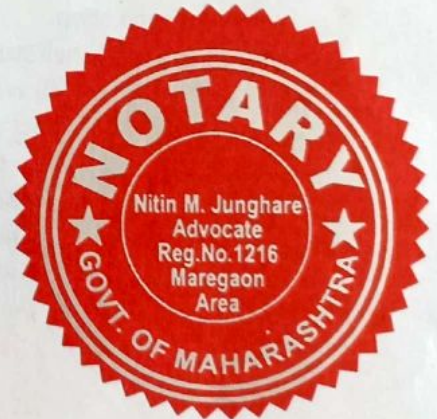


AFFIDAVIT
(Non-Proprietary Character)

The deponent herewith submits as under: -

- 1) The deponent is the president of the Swalambi Shikshan Sanstha, Wani registered under the Bombay Public Trust act 1950.Reg NO Mah 2824/1993 F-2827(Yavatmal)
- 2) That the deponent is submitting this affidavit to CBSE as it is a basic requirement that the president of the trust\society should execute an affidavit that the trust or society/management running the school is of Non-Proprietary Character and how the member of the trust society is related to each other.



- 3) That the school is being run as a community service and not as business and that commercialization does not take place in the school in any manner whatsoever.
- 4) That no part of income from the institution is being and will be diverted to any individual in the Trust/Society/School management committee or to any other person/entity. The saving, if any after meeting the recurring and non-recurring expenditure and contributions to developmental, Depreciation and contingency funds, will be further utilized for promoting the school and extending the cause of education in the same school only.
- 5) That School is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organisation or body.
- 6) That the school will not open classes under CBSE pattern particularly class IX\X\XI\XII and will not use CBSE name in any manner without obtaining affiliation.
- 7) That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation and examination byelaws and the circulars issued by the board from time to time and the law of the land.
- 8) That the school will ensure that all required infrastructure is available with the school before starting classes.
- 9) That the school will ensure that the building safety, Fire safety, Water Safety, Health and Hygiene certificate are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term
- 10) That the school will ensure that all required infrastructure is available with the school before starting classes.
- 11) That the school will ensure that sufficient number of qualified teachers as per the provisions contained in affiliation bye-laws are available with the school before starting classes.
- 12) That the school will follow the provisions related to fee contained in affiliation bye-laws and will disclose the details of the fee to the student \Parents every year before start of session without restoring to any hidden charges in the heads of the fee.
- 13) That the school will not coerce any student/parent to buy books/stationary/uniform from any particular shop.
- 14) That the school shall strive to make efforts for conservation of environment.
- 15) That the School will not start CBSE pattern classes without submitting a commencement certificate to the effect that the school has compiled with all the conditions imposed by CBSE and the post affiliation conditions contained in affiliation byelaws with the general rules.
- 16) That the school not sponsor students from other board.
- 17) That no member of School Managing Committee is related to each other.
